

iGrow Network Compliance Guidelines



iGrow Network is dedicated to following proper business practices and guidelines, and seeks to foster an environment of support and respect among our Affiliates and Associates. In order to maintain these standards and create a fair playing field for everyone, it is vital that all Affiliates and Associates follow the iGrow Network Compliance Guidelines.

- 1) Do not talk about the iGrow Network business opportunity without also sharing the iGrow Network Income Disclosure Statement (IDS).
- 2) Do not make false or deceptive claims about the iGrow Network business opportunity or products.
- 3) Do not make income claims or set unrealistic earning expectations when prospecting future members.
- 4) Do not promise that you, or others, will build an Associate's downline for them.
- 5) Do not sell iGrow Network as an opportunity that requires little or no work, or use the following words or phrases in association with iGrow Network: Investments, Hyips, Passive Income, Guaranteed Income, Easy Money, Now you can Retire, Get Rich Quick, or Make \$XXX in your first week!
- 6) Do not solicit anyone on the "it" social network to join your iGrow Network downline, even those in your network.
- 7) iGrow Network and "it" cannot be combined on public ads or posts. Publicly the "it" social network can only be promoted to free users naturally through the app invite, or by word of mouth, and not in association with iGrow Network. If you are marketing the opportunity then you market iGrow Network only. If you are promoting "it", you may not also mention iGrow Network.
- 8) The following materials may not be published in the "it" social network: adult oriented or pornographic content; hateful or overtly bigoted material; content that promotes or glorifies any illegal activity; material which contains malicious code or programming intended to disrupt the workings of the system, or to invade a user's device or account. Any infraction may result in the immediate termination of your iGrow Network and/or "it" account.

9) "it" cannot be used as bait for the \$50 iGrow Network Product Line (iNPL) sales.

10) The brand "it", iGrow Network, or iGrow University, may not be used for any group, website name or username.

11) Do not register more than one personal account. Individuals may have a personal account and a business account. The business account must have a valid EIN or other government issued business identity. Do not establish more than one iGrow Network Membership per Tax ID or EIN.

12) Do not hold any public meeting without prior approval and training from iGrow Network (private home meetings excluded).

13) Do not post negative or derogatory comments about "it", iGrow Network, iGrow Network Officers, iGrow Network personnel, or other iGrow Network Distributors, in any public forum.

14) Do not solicit other iGrow Network Affiliates/Associates (outside of your own personally referred Members) to join any other network marketing programs.

15) Do not speak on behalf of the company, or represent yourself as a corporate officer. The words "Independent Associate" must be on all marketing materials produced by any Associate. All marketing materials produced by an Associate must be submitted to compliance@igrownet.com for approval before being used.
